It is expected that the Registrant's sales and cost of sales be approximately \$4.2 million and approximately \$2.9 million for the three months ended September 30, 2009 compared to \$5.0 million and \$3.8 million for the three months ended September 30, 2008, respectively. The decrease in sales and cost of sales recorded in this quarter compared to those for the three months ended September 30, 2008 were attributable primarily to a \$0.7 million decrease in sales of our coatings products as a result of decrease in demand in oil drilling applications, a \$0.2 million decrease in our research and development contracts, which were offset by a \$0.1 million increase in sales of our parts manufactured from bulk Liquidmetal alloys to consumer electronics customers as a result of increased demand in electronic casings applications.
